RECORDS ARE WRITTEN IN TISSUES by Marcel Vogel

In previous articles, I have spoken to you about how information is stored in stone, in crystals, and in bone. I will now address how information is stored in the fluidic part of the tis-

sues in our bodies.

When a fluid spins, the act of spinning creates a weak, but discernible magnetic field around the fluid. This magnetic field can act as an information transfer system for structures that are stored in the bloodstream of our body. The red blood cells contain iron, which can be either ferro-magnetic or diamagnetic. This means that under the influence of a weak, but precise magnetic field, the cell can be oriented and locked into place. If the cells already have a configuration oriented as a result of a previous information input, then the magnetic field can extract the information contained in the bloodstream from the clustered red blood cells.

It is my belief that when red blood cells have had an information code impinged on them, a field is created external to the cell. This is similar to the magnetic domain that is on the surface of a magnetic tape of disk which stores information such as music.

I believe information is printed into the cell by the individual's mind on the indwelling breath. The indwelling breath carries the vibrational codes and acts on the cells of the body, particularly the red blood cells, which contain iron, and on the nucleus of the individual cells. which also contain iron. In the research we have done here at P.R.I., we have found that water can be structured by a crystal within a coil of fluids spinning around it. In addition, the information can be transceived and act on the water causing it to change and form what is called a lyotropic mesophase. This means that the individual clusters of water molecules are formed together into a liquid crystal pattern which are liquid (water) and crystals at the same time.

When a crystal contains information added to it by the mind of an individual, that information can be transposed to the fluid water immediately by spinning it around the crystal. When water spins, we measure a weak magnetic

field (up to .07 gauss). This field is sufficient to stimulate the information bands within the crystal and cause an abrupt, immediate change in the water. When we look at the ultraviolet spectra, we find a new band present which did not exist before. There are additional bands as well in the infrared spectra. This means both organizational and chemical changes are present. We are working at this time to interpret these changes.

We have applied this knowledge to the structuring of wine and have worked with the Sycamore Creek Winery of Morgan Hill, Ca. since January 1988, and have been successful in creating an improved taste, bouquet and body to its wines in this manner (see listing of awards for these wines on page 4 of this newsletter).

It is our belief that the same premise holds true for the human body. We structure the fluid in our body with our thoughts, especially those thoughts that have a negative connotation. The fluid then becomes bound or structured and locked in place. This results, at times, in rapid weight increase. Weight gain is not necessarily a product of excessive food intake, but rather an overloading of information (emotions, thoughts, fears), with which the body is not equipped to

cope. So the body stores it and it becomes what is commonly called fatty tissue.

When one reverses negative attitudes towards self, thinks well of others and thereby rleases the feelings that have caused the negative patterning of the tissue, there is an abrupt drop in weight, a firming of the tissue and an increased sense of wellbeing. Every cell in our body is a living reminder of who we are, what we are, how we think and what we are doing to ourselves.

To keep ourselves in a state of well-being, we must not only exercise and select healthy food, we must also think well of ourselves and give to our own inner beings the respect and honor that they deserve. We must provide our body with thanks for the work it does to keep us going and functioning as we do. To love one another we must first love ourselves and be proud of what we have accomplished with the activity of our bodies, minds and spirits working in harmony.

EXPERIMENT #73 THE EFFECTS OF THOUGHT

Materials Required:

3 clear crystals

1 Vogel-cut_{TM} Medallion (optional)

3 participants: A,B,C

Have person A in charge of the crystals. Have him/her program one crystal with the thought of a traumatic experience or with hate and anger. Person B stands between A and C. As person A places one crystal on the back base of the neck of B, person C will test the effects of that crystal on B who does not know which crystal is being tested. This is done by B extending his/her arm out straight from the side while the crystal is at the base of the neck. Person C attempts to lower the arm with a gentle, steady push downward (kinesiology). Person B offers resistance by holding his/her arm steady.

You will find that when the negatively programmed crystal is placed on the base of the neck, B's arm will not be resistant and will fall to the side. When the clear crystals are placed at the neck, B's arm will be resistant. Test this again by having A clear the negatively programmed crystal and put in thoughts of

love, health and well-being. Test the arm again and you will find there is resistance.

THE EARTH'S GRID SYSTEM

The earth's grid system consists of a series of geometrical points (locations), on the surface of the earth (see map). When these points are connected, the earth can be seen as a large polyhedron, a three dimensional object with symmetrical faces, or as a large, faceted crystal. The number of faces on the earth's surface depends upon the number of grid points: the more points, the more faces.

In recent years, several authors have written about this grid system. Interest in these lines was first raised by J. Michell in his books, FLYING SAUCER VISION and CITY OF REVELA-TION, which describe a system of straight lines (known as ley lines) that ran across his native country, France. Ancient roads and highways were used to define this "straight line" system, and Michell noticed that many old monasteries and cities had been built at locations where the lines intersected.

The majority of scientists would place the earth's grid system in the same category as psychic phenomena - because they do not understand, they do not subscribe to it. The purpose of this article is to describe the basic features, functioning and significance of this system.

This article has used the book ANTI-GRAVITY AND THE WORLD GRID, a series of writings compiled by David Childress, to describe the basic features of the Earth's Grid System. The mathematical system that is used to

describe the grid is based upon the symmetry of the quartz crystal, the rationale being that the earth is composed mostly of materials that are related to silica.

The earth's grid system is produced as a series of lines are drawn on the surface of the earth. These lines connect a series of points which are produced by the resonance of ELF (extremely low frequency) geomagnetic waves that move around the earth on its lines of magnetic longi-These lines tude and latitude. are based upon the north and south magnetic poles, while the normal lines are based upon the rotational poles (the junction of the earth's rotational axis with its surface).

The earth is ringing like a bell with these ELF waves. As they move around the earth they build in magnitude until their basic waveforms, which begin as sine waves, are transformed into overtone or harmonic waves.

Overtone waves are common in radio and music electronic technologies and are of three basic types: the sawtooth wave, which is the sum of even harmonics; the triangular wave, which is the sum of odd harmonics and the square wave, which is the sum of all harmonics. There are many other types of waves which are combinations of these basic types. In electronic music, all musical sounds, such as those of a trumpet or violin, are the result of these basic wave cominations.

In the normal sine wave, the wave nodes, or peaks, occur at

90° and 270° or 180° apart. This separation is known as the phase angle or phase separation of the wave. When an overtone waveform is produced, however, this phase angle can decrease to a much smaller angle, such as 60° or even less. This is what happens to the earth's geomagnetic waves, and this is what produces the grid pattern on its surface.

GRID SYMMETRY

The earth's grid system has a basic symmetry to it. The map of the earth shows the 12 primary points or geographical areas as black dots: five at 280 north latitude and five at 280 south latitude, with each group of five points spaced evenly at 720 intervals around the globe. Other grid systems have slightly different latitude and longitute values than the ones that are used in this article, but they are in close agreement. is, however, no agreement as to the usage of a magnetic versus a rotational system of lines of longitude and latitude.

The two main points are staggered as shown on the map. The remaining two primary points are at the north and south poles.


It is interesting to note that the pyramids in Egypt are located on the secondary points that are midway between the two primaries in the Atlas Mountains of North Africa and in Kashmir, India.

Large pyramids are similarly

located in Western China.

The grid map shows a system of 10 secondary points as black dots with crosses. These are located at 560 N and S latitude,

double the latitude of the primary wave peaks. Grid researchers have proposed a grid system that includes an additional 40 "minor" points for a total of 62 points. Twenty minor points occur halfway between the primary and secondary points, at 30° and 54° N and S latitude, while another 20 points are located around the globe at 12° N and S of the equator.

If the only geomagnetic wave action occurred between the poles then we would expect a continuous line of points or geographical areas at 28° N and S latitude, but this is not the case, as another set of frequencies are propagating parallel to the equator. These are the harmonic series that produce a wave pat-

tern with a phase angle of 72°. The interaction between these two waves causes the vibrational disturbances that are occurring at 280 N and S to group together at locations that are 72° apart. Just as the north-south wave splits into two peaks that are 560 apart, the equatorial wave splits into two sets of peaks that are 36° apart. The final result of these combined waves is the primary grid pattern of two groups of points, 72° apart at 280 N and S latitude, staggered at 36° longitudinal intervals.

GRID HARMONICS

The most fundamental question regarding the grid's wave pattern is: Why do the waves peak at (these) particular latitudes? To understand this, a com-

plex answer is required.

The grid pattern is the product of a doubly oscillating system of waves, one with a 51.430 phase angle (one-seventh the circle of 360°), and the other with a 60° phase angle (one-sixth the circle). The average of these two waves is a modulating (changing), wave pattern with a phase angle that moves between 540 and 560 (a combination of secondary and minor points), and 280 and 300 (a combination of primary and minor points). The primary pulse at 280 is the most important, as it produces the secondary pulse (its first harmonic), at 560 and the minor harmonics at 120 as well. These are produced by the total phase difference between the primary and the 360° fundamental, i.e. $360^{\circ} - 56^{\circ}(6) = 24^{\circ}; 24^{\circ}/2 =$ 120.

All of the grid harmonic patterns or angles are the result of overtone waves that have built up to harmonic levels where the phase angles that were described above are produced. The normal sine waves, in effect, have been transformed into overtone waves with the appropriate phase angles or wave divisions.

The earth's grid is probably produced by the combined resonance of the earth's magnetic and rotational (inertial) fields. The earth's rotation changes very little through time. However, its magnetic field is much more variable, and the earth's grid points tend to move around with these magnetic field changes.

If you were to travel away

from the earth's equator, toward its poles, the difference between its magnetic and inertial fields would increase. The N and S magnetic poles are located between 66° and 73° latitude, while the rotational poles are at 90° latitude. This large difference means.... the grid points closest to the poles will show the greatest influence of the magnetic field and will be positioned more in terms of magnetic latitude and longitude than in terms of rotational longitude and latitude. Under these conditions, the grid poles 900 latitude would be located part way between the magnetic and axial poles. Closer to the equator, however, the polar differ-

damental resonances that are occurring in nature that might account for the three basic wave patterns (51.43, 60 and 72°), for the grid system but some possibilities include:

1. The 51.43° phase angle is close to the interlattice or tip angle of the quartz crystal at 51.78°, and to one-half the angle of the water molecule at 104.5° and to twice the critical bonding angle of two water molecules at 26.2°. Since 84 per cent of the earth's crust is composed of silica, a quartz-related compound, and 74 per cent of its surface is covered with water, this resonance may be caused by the abundance of these two molecules in the surface of the earth.

2. The 60° phase angle is related to the hexagon, which has internal angles of 120°. This geometrical form defines the benzene ring that most organic molecules are based on and the hexagonal ring structures that occur in all of the earth's sillicates and that form snowflakes from water molecules.

3. One and one-half times the 72° phase angle is close to the bonding angle of the water tetrahedrons (109°), and hydrocarbon tetrahedrons (109.5°), the basic constituents of all living things.

The three basic waveforms that we have listed above can be related to the molecular structures of the silica rocks that make up most of the surface of the earth, and to the molecular structures of the water and organic molecules that make up

the living things that reside upon its surface as well. This does not explain why the three phase angles occur but it does lead us into an area of investigation where important substances such as quartz, water and hydrocarbons can be defined in terms of wave patterns and phase angles.

We can assume that the wave pattern and phase angles that occur in the earth's geomagnetic field are of some importance in all types of crystalline matter. Possibly, one-sixth and one-seventh phase patterns that run with the axis of a crystal, and one-fifth (72°) ones that run perpendicular to their axes are indicative of the types of wave patterns that are produced as atoms form into their crystalline states.

HEALING THE EARTH

The ELF waves that move around the earth and create its grid system are linked to its gravitational field and to its zero-point or superspace energy field as well. This is the reason that the major points were originally identified as areas where objects and people mysteriously disappeared from the surface of the earth. The Bermuda Triangle is an example of such an area. These are the areas where large crystalline resonators must be placed if the earth's gravitational field is to stabilize at the time of a major geographical disturbance.

One of the "fringe" theories of Geophysics is that earthquake activity is related to sunspot

activity. Sunspots have their origin outside the earth in disturbances that occur within the solar and planetary magnetic fields. Wave disturbances here move into the planets and cause magnetic wave imbalances which in turn, could cause earthquakes. These waves act through the earth's grid system, producing magnetic anomalies at the major and minor points within the system. If these waves are to be influenced by crystalline electromagnetic equipment, then this equipment must be placed within these areas.

There are three basic types of waves (in addition to the three phase angles). Each wave produces a particular physical quality that manifests at a particular grid point. The primary points have negative energy waves which are time-reversed and faster than the speed of light in They define entry velocity. points into the superspace continuum on the surface of the earth and are related to the earth's gravitational waves. remaining secondary and minor points are either positive energy waves, which are ordinary electromagnetic waves that produce our weather systems, or neutral energy waves, which produce forces that are related to movements in the earth's tectonic plate system.

The importance of the grid system's points cannot be underestimated. Bruce Cathie, a grid researcher, has a mathematical system that predicts the locations of a vast number of additional minor points, rather like the vast array of minor acupuncture points on the human body.

He has theorized that a nuclear blast that goes off on a grid point will have its explosive magnitude greatly increased if it does not go off on a grid point, then it will have its magnitude decreased. If it is greatly increased then the earth could be endangered, as was the case when the United States set off a 5 megaton blast under the Aleutian Islands in Alaska and earthquakes occurred through resonance in Western China near the pyramid complex that is located there. If the blast is decreased, then the energy has moved out into space on the ELF waves that move between the planets of the solar system. This energy will return sometime in the future.

The earth's grid is a phenomenon of rotational and geomagnetic fields and forces. Its geometrical symmetry is related to that of the quartz crystal. ELF waves resonate over the very wide frequency spectrum. resonant patterns that occur over these extremely wide frequency bands (from the size of a crystal to the size of a planetary orbit) are the same, and they account for the transfer of energy from the macro (planetary) systems to the micro (molecular and atomic) systems. IT IS THESE RESONANCES THAT ACCOUNT FOR THE INFLUENCES OF THE PLANETS UPON ORGANIC MOLE-CULES OF THE HUMAN BODY AND FOR GENERAL THE VALIDITY OF THE DISCREDITED SCIENCE OF ASTROLOGY.

The grid is based upon the orderly arrangement of the space around us, but its functioning is temporal, and this is the quality that will determine our futures with respect to underground nuclear blasts and to other time related events as well.
